Resolution 11-5-2019

AN RESOLUTION CERTIFYING THE ELECTION RESULTS FOR TWO FULL-TERM COUNCIL MEMBER SEATS, ONE YEAR UN-EXPIRED AND ONE FULL-TERM MAYORIAL SEAT FOR THE CITY OF BRUCEVILLE-EDDY, TEXAS; HELD IN THE CITY OF BRUCEVILLE-EDDY, TEXAS, ON NOVEMBER 5th, 2019 AND ORDAINING OTHER PROVISIONS RELATING TO THE SUBJECT MATTER THEREOF.

WHEREAS, the City of Bruceville-Eddy has held their municipal election on November 5th 2019 for the 2019/2021 terms of Mayor and two Council Member seats, and one Council Member seat for the term of 2019/2020.

Now, Therefore, be it ordained by the City Council of the City of Bruceville-Eddy that:

The Mayor at the special called council meeting held on November 18th, 2019 did canvass and announce the Election Results and found as follows; that pursuant to the applicable provisions of the Texas Election Code, the Canvassing board certifies that the following are true and correct results:

Said election was duly called; that notice of said election was given in accordance with the law; and that the canvass of the votes cast in said elections and returns thereof were made in accordance with the law.

Pursuant to the Resolution of the City of Bruceville-Eddy and applicable provisions of the Texas Election Code:

Mayor: Connally Bass, having been declared winner by a majority of votes, is hereby certified to be elected Mayor of the City of Bruceville-Eddy and shall commence his term of office upon adoption of this Resolution and the swearing to the Oath of Office as required by law.

1. City Council: Phil Reyna, having received a majority of votes cast for a total of 123 is hereby certified to be elected to the City Council of the City of Bruceville-Eddy and shall commence his term of office upon adoption of this Resolution and the swearing to the Oath of Office as required by law.
2. City Council: Rick Eaton, having received a majority of votes cast for a total of 98, is hereby certified to be elected to the City Council of the City of Bruceville-Eddy and shall commence his term of office upon adoption of this Resolution and the swearing to the Oath of Office as required by law.

3. City Council: Ricky Wiggins, having received a majority of votes cast for a total of 157, is hereby certified to be elected to the City Council of the City of Bruceville-Eddy and shall commence her term of office upon adoption of this Resolution and the swearing to the Oath of Office as required by law.

Section 2. The City Secretary of the City of Bruceville-Eddy is hereby authorized and directed to cause the caption of this Resolution to be published in a newspaper having general circulation in Bruceville-Eddy, McLennan County, Texas.

Section 3. If any part or parts of this Resolution are found to be invalid or unconstitutional by a court having competent jurisdiction, then such invalidity or unconstitutionality shall not affect the remaining parts hereof and such remaining parts shall remain in full force and effect, and to that extent this Resolution is considered severable.

CONSIDERED, PASSED, and APPROVED this 18th day of November, 2019 at a meeting of the City Council of the City of Bruceville-Eddy, Texas, at which a quorum was present and which was held in accordance with Chapter 551, Texas Government Code.

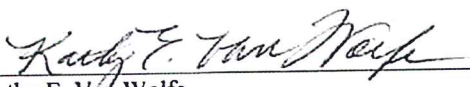
