ADVERTISEMENT AND INVITATION FOR BIDS

The City of Bruceville-Eddy, Texas, is receiving sealed bids for providing labor and materials to complete the following work at 144 Wilcox Drive, Bruceville-Eddy, Texas 76524:

Pave and stripe a street-accessed parking area per the attached sketch. The parking area consists of eight separate "pull-in, back out" parking spaces, including one (1) ADA Van Accessible space, one (1) ADA Handicap space, and six (6) regular vehicle spaces. Individual parking spaces to be per dimensions shown and positioned in the order of the schematic provided on the attached sketch.

Vendors are invited to quote either asphalt or reinforced concrete, or both.

Asphalt to include grading of area, the base material of 6 inches of crushed concrete or equivalent, packing, oil coating, and a 2" surface topping.

Concrete to include grading of area, forms and frame out, sand fill, 3/8 inch rebar on 16-inch centers across length and width of area, and a 4-inch slab of 3000 psi mix concrete. Stress joints to be cut 1" deep at 15-foot intervals across the length and width of the area.

Striping to be per attached sketch and per ADA specifications.

Concrete curb stops to be provided and placed at specified locations within each space.

Handicap Signage to be provided by the City of Bruceville Eddy.

All Bids must be received by 5:00 p.m., CT on Thursday, July 8, 2021, at the City Hall office, 144 Wilcox Drive, Bruceville-Eddy, TX 76524. All Bids received by 5:00 p.m. on July 8, 2021, by U.S Mail, in person, or by courier service will then be publicly opened and read aloud in a City Hall Council meeting on July 8, 2021, at 6:30 p.m. Bids received after 5:00 p.m. CT will be returned unopened.

The requested completion time is within 30 consecutive calendar days after award of Contract. Time is of the essence, and all work should be substantially completed within the requested time. Vendors must state an estimated time for the completion of their bids.

Bids shall be submitted on the Bid Forms provided in a sealed envelope clearly marked on the outside as SEALED BID DOCUMENTS – Do Not Open – City Street Access Parking Area - City of Bruceville-Eddy City Hall (Name of Bidder) & (Date and Time of Bid Opening)

The successful bidder must ensure that employees and applicants for employment are not discriminated against because of race, color, religion, sex, age, or national origin. The City reserves the right to reject any or all bids or to waive any informality in the bidding. The Contract may be awarded either to the lowest responsible bidder or to the bidder who provides goods or services at the best value for the City. Bids may be held by the City for a period not to exceed 30 days from the bid opening date to review the bids and investigate the bidder's qualifications before a contract award. Upon award, the successful bidder will be required to complete a Conflict-of-Interest Questionnaire, IRS Form W-9, and, if requested, to provide a Certificate of Insurance with the City of Bruceville-Eddy listed as Certificate Holder. City officials must approve all forms.
