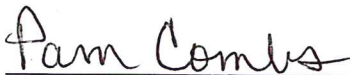

Resolution 11-15-2021

AN RESOLUTION CERTIFYING THE ELECTION RESULTS FOR TWO FULL-TERM COUNCIL MEMBER SEATS, AND ONE FULL TIME MAYOR SEAT HELD IN THE CITY OF BRUCEVILLE-EDDY, TEXAS, ON NOVEMBER 2ND, 2021 AND ORDAINING OTHER PROVISIONS RELATING TO THE SUBJECT MATTER THEREOF.

WHEREAS, the City of Bruceville-Eddy has held their municipal election on November 2ND, 2021 for the 2021/2023 terms of two (2) Council seats and one (1) mayoral seat.

Now, Therefore, be it ordained by the City Council of the City of Bruceville-Eddy that:

The mayor or his representative, at a Regular Called Meeting held on November 15th, 2021 did canvas and announce the Election Results and found as follows; that pursuant to the applicable provisions of the Texas Election Code, the Canvassing board certifies that the following are true and correct results of the November 2ND 2021 election.

That said election was duly called; that notice of said election was given in accordance with the law; and that the canvass of the votes cast in said elections and returns thereof were made in accordance with the law.

Pursuant to the Resolution of the City of Bruceville-Eddy and applicable provisions of the Texas Election Code:

1. City Mayor: Linda Owens, having received a majority of votes cast totaling 107, is hereby certified to be elected to the City Council of the City of Bruceville-Eddy and shall commence her term of office upon adoption of this Resolution and the swearing to the Oath of Office as required by law.
2. City Council: Connally Bass, having received a majority of votes cast for a total of 101 is hereby certified to be elected to the City Council of the City of Bruceville-Eddy and shall commence his term of office upon adoption of this Resolution and the swearing to the Oath of Office as required by law.
3. City Council: Richard Prater having received a majority of votes cast for a total of 98, is hereby certified to be elected to the City Council of the City of Bruceville-Eddy and shall commence his term of office upon adoption of this Resolution and the swearing to the Oath of Office as required by law.

Section 2. The City Administrator of the City of Bruceville-Eddy is hereby authorized and directed to cause the caption of this Resolution to be published in a newspaper having general circulation in Bruceville-Eddy, McLennan County, Texas.

Section 3. If any part or parts of this Resolution are found to be invalid or unconstitutional by a court having competent jurisdiction, then such invalidity or unconstitutionality shall not affect the remaining parts hereof and such remaining parts shall remain in full force and effect, and to that extent this Resolution is considered severable.
