4. Municipal Utility District Proposal – Joe Birdwell

Council to discuss and consider a forthcoming petition of consent for the creation of a municipal utility district (MUD) by the property owner for the inclusion of land residing in the extraterritorial jurisdiction of the City limits of the City of Bruceville-Eddy. General location of land is south of Franklin Road at the corners of McLennan, Bell, and Falls Counties. Council will hear a presentation from a representative of American Southwest Company regarding initial plans for the site and speak to the draft consent resolution.

Mr. Joe Birdwell and Mr. Berge were present to give a presentation regarding the MUD south of Franklin Road at the corner of McLennan, Bell, And Falls County. He was asking for a consent from the city council because some of this property is in our ETJ.

Motion made by Connally Bass I vote we postpone the consent for this MUD until our next council meeting, 2nd by Richard Prater, yeas 4, nay 0, absent 1, motion passes.

6. Proposal for General Engineering Services

Council to discuss, consider, and possibly take action to approve the City Administrator to enter into an engineering services agreement for the purpose of providing general engineering services.

Motion made by Ricky Wiggins, that we send this agreement to our attorney and have them look over it and suggest the modifications that he sees we need to make on our behalf and get with MRB Group to see what they say. 2nd by Richard Prater, yeas 4, nay 0, motion passes

7. Interlocal Agreement for Street Repairs

At the recommendation of the Budget Committee, Council to discuss, consider, and possibly take action to approve the City Administrator to enter into an interlocal cooperative agreement with McLennan County for the purpose of authorizing McLennan County Precinct 1 - Road and Bridge crews to reclaim, setup, prime, and chip seal named streets in an estimated amount of \$30,175, as approved in the FY 2022-2023 adopted budget.

This money will cover Temple (South of 3rd St), Ausborn St, Archie Ln (not including unimproved section), N. Mesquite St., and Crescent Creek.

Motion made by Graham McGruer to approve the City Administrator to enter into an interlocal cooperative agreement with McLennan County for the purpose of authorizing McLennan County Precinct 1 - Road and Bridge crews to reclaim, setup, prime, and chip seal named streets in an estimated amount of \$30,175. 2nd by Ricky Wiggins, yeas 4, nay 0, absent 1, motion passes.

8. Ratification of Booster Pump Repairs - Friendly Oaks

Council to discuss, consider, and possibly take action to approve staff expenditures for the replacement of failed motors on the Friendly Oaks booster/distribution pumps; approval of payment to Jurgensen Pump, LLC in a total amount of \$10,402.00.

Motion made by Connally Bass I move we agree to pay the \$10,402.00 for repairs to the Friendly Oaks booster/distribution pump. 2nd by Graham McGruer, yeas 4, nay 0, absent 1, motion passes.
