City Administrator did show a slide with the estimate rates for the sewer.

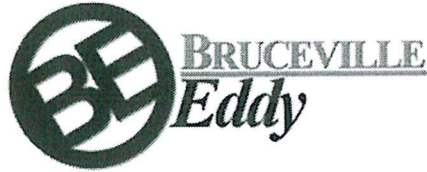


5. Ordinance Authorizing Issuance of Certificates of Obligation – Series 2024B



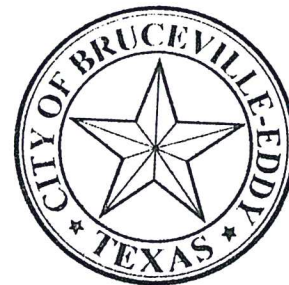
