 If the Bed and Breakfast Facility or Short Term Rental Facility is residentially zoned, all lighting must be directed
toward the establishment and not at adjacent properties. All signs must comply with Sec. 4.05.008 (c) of the B&B Facilities and STR Facilities ordinance

#### ADDITIONAL REQUIREMENTS

The full list of requirements is detailed in Chapter 4, Article 4.05 – Bed and Breakfast Facilities and Short Term Rental Facilities. Below is a summarized list of requirements.

- A Bed and Breakfast Facility license or Short Term Rental Facility license shall be valid for a period of one year from the date of issuance.
- 2) A Life Safety Inspection of the applicant's property must be approved by the Community Development Department
- 3) The designated operator shall be present in McLennan, Falls, or Bell County and available at all times the property is being rented. Contact information shall be furnished to owners of real property within 200 feet of the Bed and Breakfast Facility or Short Term Rental Facility.
- 4) A sign with contact information, license number, occupancy limits, and parking requirements as set forth in Sec. 4.05.007 (e) of the ordinance must be posted conspicuously in the common area of each unit.
- 5) Distance and density requirements detailed in Sec. 4.05.008 (a) of the ordinance shall be applied.
- 6) The license or any renewal may be denied, suspended, or revoked if the above conditions and those listed in the license ordinance are not complied with and maintained for the license period. Any person or entity denied a license or renewal or from whom or from which a license was suspended or revoked may appeal such denial to the City Council following the procedures outlined in Sec. 4.05.010 of the ordinance.

Narrative (short summary of what is being proposed for the property and how it will be managed)
Record of payment of hotel occupancy taxes for the previous period or duration of operation (if applicable)
Certificate of Occupancy issued within the last 12 months (if applicable)
Pictures of existing/proposed parking area
Proof of ownership
If property owned by corporation, a certificate of formation is required with proof of authority to sign.
Life safety inspection performed by Bruceville-Eddy staff of property if Certificate of Occupancy not issued within last 12 months (if applicable)
