RE: CITY OF BRUCEVILLE-EDDY Monthly Engineering Status Report

Mr. Kent Manton,

MRB Group is pleased to provide to the city the following Items in regard to the Monthly Engineering Report. This report includes Engineering Tasks from May 15th through June 12th, 2024.

DEVELOPMENT REVIEW

1. CEFCO –We recommend approval of plat pending minor revisions to the Final Plat certifications. We prepared a Preliminary OPC for the project to develop permit fee amounts on May 29th, 2024, in the amount of \$4,050,000.00

WATER METER FEASIBILITY

We reviewed (1) commercial water meter investigations. The meter study was for Nuresh Maknolia. The proposed meter feasibility study was approved, however, the meter installation required system upgrade. The developer requested preliminary system upgrade description and the associated cost estimate. MRB proposed a new 8" water main roadway bore under IH 35 to service the proposed development. The proposed improvement was estimated at \$375,000.00

GENERAL DISCUSSION ITEMS

- 1. Water System 8" Water main Improvements: The project is scheduled for bid opening on Thursday June 13, 2024. A bid tabulation along with a contractor recommendation will be forwarded to city staff as soon as it is available. We anticipate the contract award in late June 2024. The overall construction schedule for this project is estimated to be 8 months or a substantial completion date of March 2025.
- 2. New Water Well: This project is in a holding pattern until funds are appropriated by the city. The cost estimate for the project is approximately 6 million dollars. This cost will





fluctuate until final design and a funding mechanism is chosen by the council. The next step would be approving an Engineering proposal to start final design.

3. Engineering Proposal for Development of Capital Improvement Program (CIP) MRB prepared an Engineering proposal to provide a city-wide Capital Improvement Program and was submitted to staff on May 31, 2024. The proposed CIP will be formatted and include items required by the state statutes to support the proposed Impact fee calculation.
