

**BRUCEVILLE-EDDY MUNICIPAL COURT OF RECORD NO.1**  
**SWORN DECLARATION OF ELIGIBILITY FOR DEFERRED DISPOSITION FOR TRAFFIC**  
**CITATION WITHOUT REQUIREMENT OF APPEARING IN COURT (revised 08/19/24)**

**Eligible**-A person is eligible to have a case dismissed by completing deferred disposition under a standing order if:

- (1) the request is made before the appearance date on the original citation or notice to appear or before any date to which that initial appearance date has been extended or reset;
- (2) the person holds a valid (eligible) driver’s license or permit or is a member, or the spouse or dependent child of a United States military forces serving on active duty; and provides proof to the Court
- (3) the person provides proof to the Court of minimum liability insurance required by Chapter 601, Texas Transportation Code.
- (4) The Defendant is at least 25 years of age, or if less than 25 years of age agrees to complete a driving safety course approved under Chapter 1001, Texas Education Code;
- (5) Enters a Plea of: \_\_\_\_\_ No Contest or \_\_\_\_\_ Guilty. (Check One)
- (6) Pay Fee of **\$334.00** Cashier’s Check, Money Order, or at [www.bruceville-eddy.us](http://www.bruceville-eddy.us). **NO PERSONAL CHECKS ACCEPTED**

**Not Eligible**-A person is **NOT ELIGIBLE** for deferred disposition under this standing order if:

- (1) the person holds a **commercial driver’s license (CDL)** or held a CDL at the time of the alleged offense;
- (2) the violation is alleged to have occurred in a **construction zone with workers present**;
- (3) the offense charged is **passing a school bus while loading or unloading students**;
- (4) the person is charged with **speeding more than 20 mph over the posted speed limit on a city street**;
- (5) the person is charged with **speeding more than 25 mph over the posted speed limit on I-35 or frontage road**;
- (6) the person is charged with **speeding more than 10 mph over the posted speed limit in a school zone**;
- (7) the defendant has been on deferred disposition in this court within the previous 12 months; or
- (8) the defendant is currently on deferred disposition with any court at the time of the request or has been on deferred disposition in any court within the previous 12 months.
