City Administrators Report: 10/24/2024

Oncor Franchise Agreement

Our City Attorney's office is still reviewing and making revisions to the franchise agreement ordinance as requested by City Council at the August meeting.

Casey Simpson, Area Manager for Oncor, has asked me to see if there are any outstanding issues in the city that have not yet been resolved in regards to some of the community's concerns that were raised at this meeting. If there are still active issues that they need to be addressed, please contact me directly so that I can pass them along.

Community Development Specialist Position

The posting for the Community Development Specialist position went live on October 1st. To date, we have not received any new applicants. The Mayor, Chief Dorsey, and I have been discussing potential alternative structures to the make-up of the position so that we might be able to staff the vital operations this position is currently designed to serve.

Health Insurance Discussion and Wellness Event

As previously requested, at one of the upcoming council meetings, an item will be placed on the agenda for the discussion of our current health insurance offerings to employees. We have been working behind the scenes to answer some of the outstanding questions regarding our legal responsibilities for the provision of these benefits.

Props to Esther Moreno, our benefits coordinator, for organizing a successful wellness screening event here at the city this past month! TX Health Benefits, our plan administrator, offers these clinics at no cost to participating cities to provide on-site prevention screening services to employees. The Cities of Lorena and Bruceville-Eddy sent staff to this

event for consultations with a focus on encouraging early detection of chronic diseases as well as best practices for healthy lifestyles.

Sewer System

In case you missed it, construction has commenced! The first stretch of mainline was installed on Evergreen in downtown Eddy. Additionally, site work has begun on the lift stations and the WWTP.

Staff have been busy responding to citizen and contractor requests for information. We have also been working hard to obtain the needed right of entry forms needed by our customer service line contractor to access properties for installation and septic tank decommissioning. To date, we have received 142 of the 312 needed forms.

On 10/17/2024 the Mayor and I met with the appropriations lead for Congressman Pete Sessions office to discuss the sewer project and how their funding is desperately needed to add in new sections for the sewer system to ensure continued affordability. The team still believes this would be a great use of taxpayer funding and that it has an excellent viability. However, Jackson reiterated that the appropriations process is very competitive as Mr. Sessions represents 14 counties across Texas and only a handful of these bills are allowed each cycle.

We have been requested to get with Tabor and Associates to create an opinion of probable cost for a proposed new section(s). Afterwards, we will be reaching out to a consultant who is highly adept at working through successful appropriation funding requests for a proposal.

Water System

Falls County Water Well

No additional updates at this time.

Rate Analysis - TRWA

No additional updates at this time.

Friendly Oaks

This wellsite is currently online.

Joseph Kotrla, with McCreary & Associates, Inc. installed electrical monitoring equipment in line with his recently approved proposal. As of writing this report, we are still awaiting the results of their findings and recommendations.

LCRR Compliance

After a year's worth of work, our efforts to comply with the newly mandated Lead and Copper Rule Revisions have been completed! A big round of applause goes to your Public Works Director, Gene Sprouse, who has spent countless hours investigating and inventorying all of our 2063 water connections!

The submission was made on the due date of 10/16/2024. We still have some public information requirements to meet, but all in all, we are now moving into the next phase of compliance which will require continual maintenance of this inventory into perpetuity.

In summary, no lead connections were identified within our system.

Grants Updates

CDBG (Waterline Improvements in-between 3rd and 4th Street)

On October 16th, Esther and I attended a regional stakeholder consultation and award kick off meeting at HOTCOG in Waco. The project period will commence in February of 2025 and we will have two years to complete the work. In attendance were both our project's engineering firm (5M and Associates) and grant administrator (Public Management).

This project will likely not be going to bid until sometime in Spring or Summer of 2025.

I have informed Tabor and Associates of the conflicting work, and he has requested that the work not commence until the sewer has been installed in this area as it was originally planned for first.

Committee Updates

Infrastructure Planning Committee

No additional information at this time. Staff are still working through various recommendations from our last meeting.

Economic Development Corporation

Directors were invited to the most recent meeting of the McGregor EDC earlier this month.

The next meeting is scheduled for 5:30 p.m. on 11/13/2024.

Development

Commercial Activity

Mrs. Monique Moser is making plans to renovate the old blacksmith shop in downtown Eddy (102 4th Street). This property was previously limited by a lack of a wastewater solution, but with the addition of the sewer system, it has now become a viable property that could potentially be outfitted for commercial activity. Monique will be coming to a workshop at our 11/21/2024 meeting to solicit suggestions on how this building could best serve the community.

WBW (Fowler Land):

On 10/3/2024 I met with representatives of WBW Development to discuss their proposed Eagle Prairie project. As a reminder, this property is adjacent to the BEISD campus along Eagle Drive.

The project allegedly has interest from several major builders as it is primely positioned near adequate infrastructure with easy access to I-35. I have been told that this project would move quickly into the plating and construction phase should they be able to design a subdivision that meets both the goals and desires of the community as well as the marketable lot characteristics they believe are sought by 'the market'.

Going forward, their plan is to create several different site plans iterations and present/gather feedback from both the community at large as well as some of the citizens who have voiced concerns with the past site plan versions.

KBAR - Eagle Ranch:

No additional information at this time.

FM 1239 Subdivision:

A developer recently purchased a large tract of land in between F.M. 1239 and C.R. 459 in Falls County. They have submitted a water feasibility study for 266 meters as they desire to plat for single family homes. This property is located outside of our ETJ and therefore would only be subject to Falls County subdivision ordinance requirements. This property is of course located within the current area of our active development moratorium. As a reminder, anyone desiring to pay the full cost of the required infrastructure improvements would be exempt from these limitations. Our engineering firm will review the developers' plans and provide them with an opinion of probable cost for further consideration.

BE Travel Center (Ascent):

Construction on the building continues at a steady pace. As of the week of 10/17/2024, our contracted inspection firm, Bureau Veritas, has passed a majority of the gas tanks, the flatwork, and provided a partial pass of the underground electric work.

On 10/16/2024, the developer submitted plans for the previously mentioned watermain extension that will extend across the property. Clarke and Associates out of Temple was hired as the design firm. MRB Group is currently reviewing the plans for conformance with our subdivision design criteria. Ascent Travel Center will be charged the costs associated with this review via our 'pass thru' ordinance.

CEFCO:

As of 9/24/2024, CEFCO is still awaiting the Casey's acquisition to be finalized before moving forward. I have been informed that the Bruceville-Eddy store is "kind of in purgatory until closing takes place".

Deer Creek MUD

Mr. Kent Manton,

MRB Group is pleased to provide to the city the following Items in regard to the Monthly Engineering Report. This report includes Engineering Tasks from August 15th through September 18th, 2024.

DEVELOPMENT REVIEW

1. CEFCO –Casey's General Stores has announced the purchase of nearly 200 CEFCO stores. The Bruceville -Eddy CEFCO Store has been put on hold until new direction is established by the new owners.

WATER METER FEASIBILITY

We analyzed and submitted recommendations for (2) residential water meter investigations. The proposed meters were located at 216 Hungry Hill Rd and 1744 Winchester Rd. Both of these installations were approved with no required system upgrades.

GENERAL DISCUSSION ITEMS

- 1. Water System 8" Water main Improvements: The project Falls County Water Main Improvements Phase 1 was awarded to Southern Contractors Group in July of 2024 for the amount of \$1,048,725.00. The contractor as of today's date is approximately 75% complete with all work. We anticipate Southern Contractors completing all work by end of October 2024. The project is currently a month ahead of established schedule.
- 2. New Water Well: This project is in a holding pattern until funds are appropriated by the city. The cost estimate for the project is approximately 6 million dollars. This cost will fluctuate until final design and a funding mechanism is chosen by the council. The next step would be approving an Engineering proposal to start final design.



3. Engineering Proposal for Development of Capital Improvement Program (CIP);. The City elected to pursue GLO planning funds for this project and are currently seeking a company to assist with project application and grant administration.
