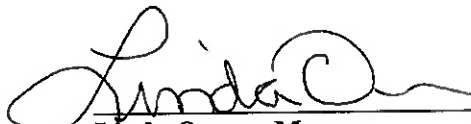
C. Possible Action on Issues Discussed in Executive Session
